I understand that at the conclusion of this heavy vehicle training I will be required to demonstrate sufficient competencies during a vehicle on road test and that should I fail this test additional costs will be incurred to retrain and re-sit additional tests.

I understand that any package offered includes hours of training which may be reasonably necessary for an average competent driver to learn the necessary proficiencies required and that any additional hours of training required by me may be at my own additional cost.

I understand that once lessons are booked, late attendance will require lessons to be cut short whilst finishing on time. I also understand that it is a government requirement that licence testing is required to start on time and failure to be at the agreed starting point for any testing on time may cause this test not to be carried out and forfeiture of all testing fees paid.

I understand that government fees (Service SA) for adding an additional class to my driver's licence to the appropriate commercial class upon successful completion of this training are not included.
